


Northern shrimp (Pandalus borealis) in Division 4.a West (Northern North Sea, Fladen Ground)

ICES advice on fishing opportunities

ICES advises that when the precautionary approach is applied, there should be no targeted fisheries on this stock for the year 2020 and 2021. ICES cannot provide catch advice on the status of this stock, because of a lack of sufficient survey and catch data.

Stock development over time

The available information is inadequate to evaluate stock trends. The state of the stock is therefore unknown. Landings since 2003 have been very low.





Stock and exploitation status

ICES cannot assess the stock and exploitation status relative to the maximum sustainable yield (MSY) and precautionary approach (PA) reference points, because the reference points are undefined.
