ICES stock advice

ICES cannot give catch advice for this stock for 2017 and 2018. ICES recommends that catches should not increase unless there is evidence that this will be sustainable.

Stock development over time

Landings peaked in 1987. Even though the fishery is not restricted, landings have been close to zero since 2005.




Figure 5.3.49.1 Norway pout in Division 6.a. Official landings (in thousand tonnes).

Quality of the assessment

The available information on Norway pout in Division 6.a is inadequate to evaluate stock status or trends.

Issues relevant for the advice

Norway pout is a short-lived species. Recruitment is highly variable and influences the spawning stock and total biomass rapidly. The default ICES approach to MSY-based management for short-lived species is an escapement strategy, i.e. to maintain SSB above MSY B_{escapement} after the fishery has taken place. At this stage is not possible to define the details of an approach suitable for this area, although it is clear that information on incoming year class strength is an important requirement.
